5.The petition is ordered accordingly.

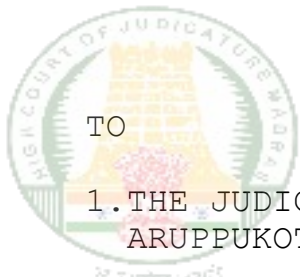
