2.Recording the said submission, this miscellaneous petition is allowed.

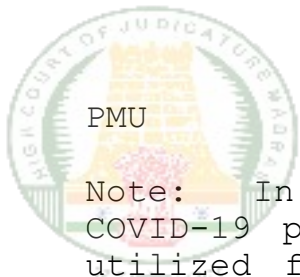
