Prayer in CRL RC(MD) . 901/ 2021 :

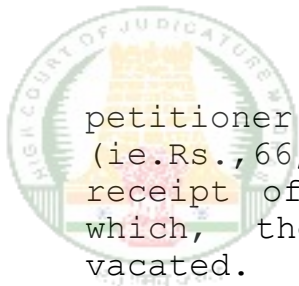

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.P.SANTHOSHKUMAR, Advocate for the petitioner, While admitting the CRL.RC, the court made the following order:-

This petition is filed to stay all further proceedings in S.T.C.No.137 of 2019, on the file of the Judicial Magistrate No.1, FTC at Magistrate Level, Madurai, pending disposal of the above Criminal Revision.

2. The learned counsel for the petitioner submitted that the petitioner is ready and willing to deposit the entire cheque amount (ie.Rs.,66,204/-) before the trial Court.
