PRAYER :-

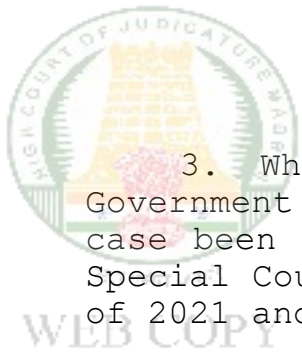
For Anticipatory Bail in Crime No. 2 of 2016 on the file of the respondent Police.

ORDER : The Court made the following order :-

The petitioner/Accused No.1, apprehending arrest at the hands of the respondent police for the alleged offence punishable under Sections 409, 477-A I.P.C. and Section 13(2) r/w 13(1)(c)(d) of Prevention of Corruption Act, 1988 in Crime No.2 of 2016 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner/Accused No.1 during his tenure as Panchayat President of Thiruppachethy along with Accused No.2 has committed irregularities. Hence, the complaint.
