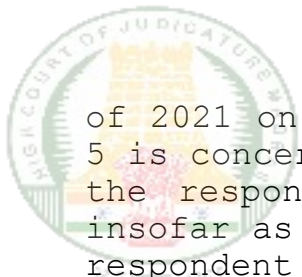

2.The learned counsel for the petitioners submitted that the petitioners have been complying with the condition imposed by this court in Crl.O.P.(MD)No.6421 of 2021 on 12.08.2021 regularly and he prayed for relaxation of the said condition.

3.The learned Government Advocate (Crl.Side) submitted that the petitioners have been complying with the condition regularly and the fourth petitioner is having previous offence.
