This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD)No.16206 of 2021 on 25.10.2021.

2. The learned counsel for the petitioners submitted that the petitioners have been complying with the condition regularly and he prayed for relaxation of the said condition.

3.The learned Additional Public Prosecutor submitted that the first petitioner has been complying with the condition regularly and the second petitioner has complied the condition only for 11 days and investigation is still pending.

4.Taking into consideration of the submissions made by both the counsels, the condition imposed by this court in Crl.O.P.(MD) No.16206 of 2021 on 25.10.2021 is relaxed in respect of first petitioner and the first petitioner shall report before the



respondent police as and when required for interrogation and modified in respect of the second petitioner and the second petitioner shall report before the respondent police once in a week i.e., on every Monday at about 10.30 a.m., until further orders.
