PRAYER :-

For Anticipatory Bail in Crime No.not known of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

Today, (ie., 10.12.2021) when the matter is taken up for hearing, the learned counsel for the petitioner would submit that there was sale transaction issue between the petitioner and the *defacto* complainant and the *defacto* complainant failed to pay the balance amount, upon which, complaint was lodged by the *defacto* complainant against the petitioner.

2.It appears that there was sale transaction dispute between the parties and the respondent police may not have any role to enquire the parties. Based upon the complaint given by the *defacto* complainant, Current Paper (CP) dated 19.08.2021, enquiry is pending.

3.Since, there is no case registered against this petitioner, the question of anticipatory bail does not arise. If any trouble arise in future, he may seek remedy through appropriate proceedings.



4. Accordingly, this Criminal Original Petition is disposed of.
