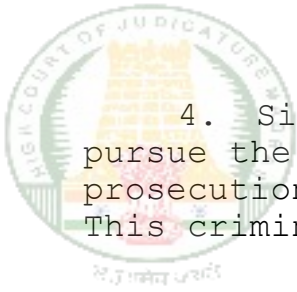

2. This criminal original petition has been filed for quashing the proceedings in C.C.No.6 of 2021 on the file of the District Munsif cum Judicial Magistrate Court, Thiruchuli.

3. The defacto complainant Krishnasamy is present in person before me. He has been duly identified by Thiru.G.Muthu Mariappan, SSI, attached to the first respondent police station. The parties have filed a joint compromise memo. The defacto complainant states that he does not want to pursue the matter.
