PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in Crime No. 13 of 2014 on the file of the respondent Police.

ORDER : The Court made the following order :-

The petitioner/Accused, seeking anticipatory bail in respect of CC No.65 of 2016 on the file of Additional Mahila Court, Madurai, for the offences punishable under Sections 498(A), 406, 506(ii) IPC r/w Section 4 of Tamil Nadu Prohibition of Women Harassment Act.

2.Entire CD file perused. It shows that this petitioner was shown as absconding accused in the final report. Now, the trial Court issued summons for appearance of the petitioner.

3.At this stage, the question of anticipatory bail does not arise. Hence, the petitioner is directed to appear before the trial Court, on receipt of summons. The trial Court may not insist the



petitioner to obtain anticipatory bail and instead of that the trial Court may get appropriate bond from the petitioner, for appearance under Section 88 Cr.P.C. from the the petitioner.
