2.When the matter is taken up for hearing, the learned counsel for the petitioner seeks permission of this Court to withdraw the present petition. But the learned counsel for the respondents submitted that the conditional order passed by this Court has not been complied by the petitioner.

3.The learned counsel for the petitioner submitted that after filing of this petition a petition has been filed before the concerned Magistrate Court stating that Rs.88,000/- must be paid being the arrears amount. There is some dispute with regard to the total arrear amount. He is ready to pay the balance amount before the concerned trial Court.



4.Recording the submission made on either side, this criminal original petition is dismissed as withdrawn. Consequently, connected miscellaneous petition is closed.
