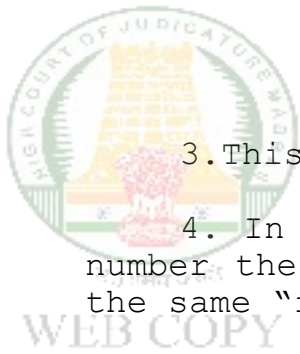
PRAYER IN CRP(MD)No.SR45962 of 2018:
