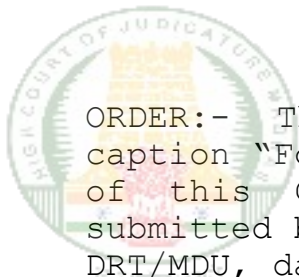

Writ Petition filed under Article 226 of Constitution of India, Praying this Court to issue a WRIT OF CERTIORIFIED MANDAMUS calling for the records issued by the first respondent dt 26.10.2020 vide proceedings Kdis D4/17733/2020 and pursuant order of the 2nd respondent dt.28.12.2020 in Roc.No.A5/3186/2020 and quash the same as illegal and unconstitutional and consequently direct the respondents 3 and 4 to redeliver the secured properties measuring an extent of 4050 Sq.ft bearing Plot No.62, comprised in R.S.No.196/1,2,3,4 and 5 Vijayagarav Mudaliyar Chatram Village, Palayamkottai, Thirunelveli District, together with residential House building at Dr.No.1000, Saragam IOB Colony, Palayankottai Ward, Thirunelveli District to the petitioner.
