Prayer in Crl.MP(MD)No.11400 of 2021 :- This Criminal Miscellaneous Petition is filed under Section 482 of Cr.P.C., to relax the condition imposed by this Honble Court on the Petitioner by order dt.20.10.2021 in Crl.MP.(MD).No.7979 of 2021 in Crl.A.(MD).No.339 of 2021.

Prayer in Crl.A(MD)No.339 of 2021:- This Appeal is filed under Section 14A(2) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act 1989 as amended by Act 1 of 2016, to call for the records relating to the order, dated 30.07.2021 made in Crl.M.P.No.1184 of 2021 on the file of the Sessions Judge, Special Court for Trial of SC/ST (POA) Act Cases, Virudhunagar District and Srivilliputhur, and set aside the same and enlarge the appellant on bail.
