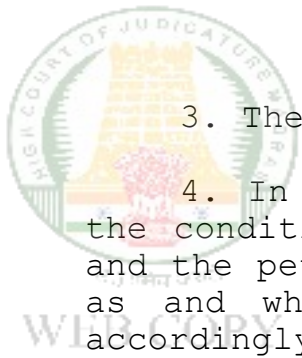
PRAYER IN CRL RC(MD)No. 363 of 2020:
