Prayer in WP(MD). 22729/ 2019 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of Certiorari and Mandamus Calling for the records culminated in the impugned notice dated 11/10/2019 on the file of the 2nd respondent and quash the same as illegal, unlawful, without jurisdiction and without any authority not binding on the petitioner and consequentially directing the respondents 1 and 2 not to alter or change the survey sketch and record in respect of the property belonging to the petitioner comprised in Old S.F.227/2 admeasuring to an extent of Acre 2.36 Cents corresponding to New Ward No. A W, Block 12, New T.S, No.12 Part, Old Door No.203, New Door No.65.
