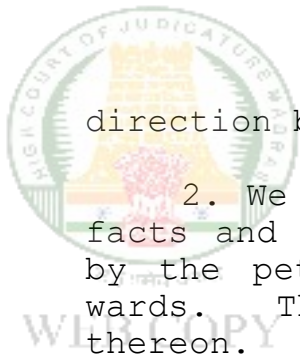

ORDER

The writ petition has been filed seeking direction on the respondents for consideration of the representation made by the petitioner on 29.07.2021. It is for reservation of the wards in favour of the Scheduled Community for the period 2021-2031. It is stated that the representation made by the petitioner has not been considered or decided by the respondents and thus, appropriate

3. In view of the above, we dispose of the writ petition with a direction to the respondents to consider the representation dated 29.07.2021 expeditiously and take a decision thereupon, with a copy to the petitioner.
