ORDER:- This Civil Revision Petition coming on for orders on this day under the caption "for extension of time" and upon perusing the earlier orders of this Court dated 26.02.2021, 22.10.2021 and 10.01.2022 and requisition letter submitted by the Principal District Judge, Kanyakumari at Nagercoil, vide letter in D.No.4245/22, dated 06.05.2022, this Court made the following order:-

When the matter came up before this Court on 17.06.2022, this Court called for some report from the Registrar(Judicial) and he has also submitted the said report before this Court.

2.Now the learned counsel for the appellants would submit that the matter is remitted back to the trial Court for disposal of the suit within the time stipulated by this Court. Therefore the trial Court is seeking extension of time. Now the learned counsel for the appellants would submit that they have filed an I.A in the said suit and challenging the order made in the said I.A, they have filed Civil Revision Petition in C.R.P(MD)No.1170 of 2022 before this Court and the proceedings of the trial Court has been stayed. Therefore, the trial Court is not able to dispose of the case within
