directions:-

"(a) The petitioner shall surrender before the jurisdictional Court on 03.01.2022.

(b) The jurisdictional Court is directed to accept the said surrender and also dispose of the bail petition to be filed by the petitioner on the same day of surrender on merits and in accordance with law.

(c) The petitioner as well as the police authorities are directed to intimate the defacto complainant about the proposed surrender on 03.01.2022."
