2.In view of the above, this Writ Petition is dismissed as withdrawn. No costs. Consequently, connected miscellaneous petition is closed.

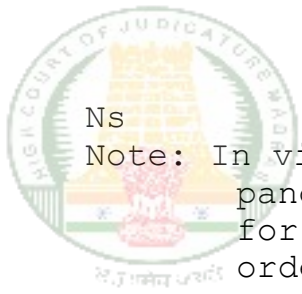
