3.The learned Government Advocate (Crl. Side) submitted that the petitioners have complied the condition regularly and investigation is still pending. But the second petitioner is having one previous against him.

4.Taking into consideration of the submissions made by both the counsels, the condition imposed by this court in Crl.O.P.(MD) No.16512 of 2021 on 28.10.2021 is relaxed in respect of first



petitioner and the first petitioner shall report before the respondent police as and when required for interrogation and modified in respect of the second petitioner and the second petitioner shall report before the respondent police once in fifteen days at about 10.30 a.m., until further orders.
