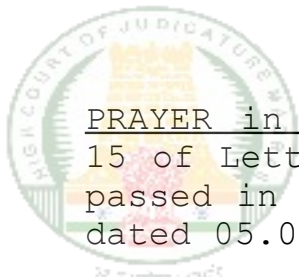

It is submitted by learned counsel for the petitioner/appellant that the matter has become infructuous.

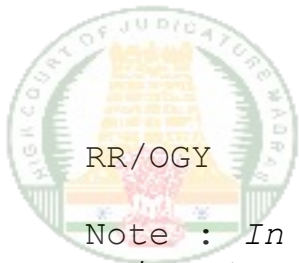
