Prayer in S.A.No.824 of 2001:-

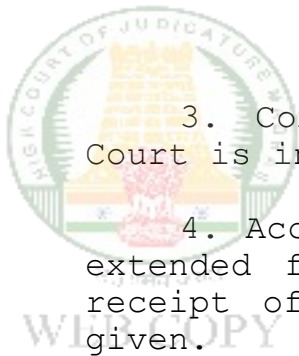
