Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents 1 and 2 herein to refix the scale of pay of the petitioner as Rs.2610-60-3150-65-3540 on par with the refixed scale of pay of the post of 'Sirappu Kavalari' with the effect from 01.04.2000 along with monetary benefit and disburse the arrears of revised scale of pay with effect from 01.04.2000.

O R D E R

This writ petition has been filed by the petitioner, directing the respondents 1 and 2 to refix the scale of pay of the petitioner as Rs.2610-60-3150-65-3540 on par with the refixed scale of pay of the post of 'Sirappu Kavalari' with effect from 01.04.2000 along with monetary benefit and disburse the arrears of revised scale of pay with effect from 01.04.2000.

2.The case of the petitioner is that he was appointed as 'Kavalari' in Thenthiruvarangathu Alvar Temple, Kanyakumari District, on 01.04.2000. At the time of his appointment, his pay scale was fixed as Rs.120-10-220-15-250 and Rs.10/- was fixed as yearly increment. While so, on 10.06.1998, the Government of Tamil Nadu issued G.O (Ms) .No.257, (Department of Tamil Development -



Culture and Religious Endowments) and revised the scale of pay for the post of Kavalalar. As per the said G.O, the revised scale of pay should be given from the month of June 1998 and the arrears of the revised scale of pay should be paid with effect from 01.07.1997 in four installments. Pursuant to which, the petitioner's scale of pay was revised as Rs.600-30-900-35-1250- with effect from 01.08.2001, without following the G.O.Ms.No.257. Therefore, in order to avail the benefits under G.O.Ms.No.257, the petitioner has made a representation on 03.02.2016. So far the respondents have not taken any action on the petitioner's representation. Hence, the present writ petition is filed.

3.The learned counsel appearing for the petitioner submitted that the very same issue came up for consideration before this Court in W.P(MD)No.7187 of 2006 and the said writ petition was allowed on 21.04.2011 with a direction to the respondents therein to grant benefits as per G.O.Ms.No.257 to the petitioner therein. Hence, the petitioner herein similarly placed person is entitled to receive salary on par with other employees, as per G.O.Ms.No.257, 10.06.1998. Hence, he prays for allowing the present writ petition.

4.Heard the learned counsel appearing for the petitioner, the learned Government Advocate appearing for the first respondent and the learned Standing Counsel appearing for the second respondent and perused the materials available on record.

5.In view of the submissions made on either side, this Court direct the respondents to consider the petitioner's representation dated 03.02.2016 and extend the benefit of G.O.Ms.No.257, (Department of Tamil Development - Culture and Religious Endowments), dated 10.06.1998, and pass orders on merits and in accordance with law, if the said G.O is applicable to the petitioner, within a period of twelve weeks from the date of receipt of a copy of this order.

6.With the above direction, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
