2. Accordingly, this Writ Petition is dismissed as withdrawn. Consequently, connected Miscellaneous Petition is also closed. No costs.

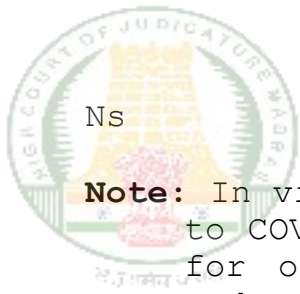
