COMMON ORDER

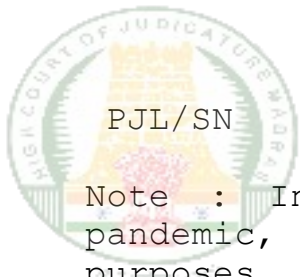
When these matters are taken up for hearing, it is represented by the learned counsel for the petitioner in all these writ petitions that the issues raised have become infructuous.
