PRAYER :-

For Bail in Crime No.773 of 2021 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/Accused No.1 herein, who was arrested on 11.12.2021 for the alleged offence under Sections 379 of IPC r/w. Section 21(1), 21(2) Mines and Minerals (Development and Regulation), in Crime No.773 of 2021, on the file of the respondent police, seeks bail.

2.The case of the prosecution is that the petitioner said to have illegally transported of sand through the lorry. Hence, the complaint.
