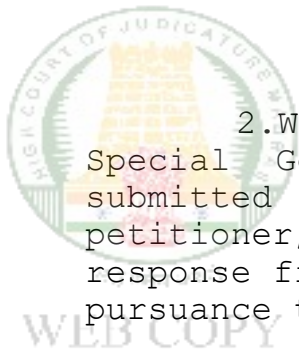

**ORDER**

On the last occasion, this Court made the following observation:

When the matter is taken up for hearing today, the learned Special Government Pleader appearing for respondents 1 to 5 submitted that despite every effective steps taken to contact the petitioner, they could not contact the petitioner and there is no response from the petitioner, in regard to the action to be taken in pursuance to the request made by the authorities.

3. In view of the above, this Court is not inclined to keep the writ petition pending any further and therefore, the same stands dismissed. However, it is open to the petitioner to approach the authority concerned with fresh application, if he is so advised. No costs.
