PRAYER in WP(MD) No.21322 of 2018: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records of the impugned proceedings of the first respondent in G.O.(4D) No.12 Micro, Small and Medium Enterprises [EL (1)] Department dated 31.08.2018 refixing and revising the seniority of the petitioner and the respondents and the consequent impugned proceedings G.O.(4D) No.14 Micro, Small and Medium Enterprises [EL (1)] Department dated 18.09.2018 finalising promotion panel by the first respondent and quash the same, as illegal and arbitrary and consequently direct the respondents to



restore the seniority of the petitioner as per 06.05.2010 proceedings of the first respondent.

PRAYER in WP(MD) No.21237 of 2017: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to place the petitioner in the promotion panel to the post of Manager (Village Industries and Administration) in category II of Tamilnadu Industries Service above the fifth respondent as per petitioner original seniority obtaining in the posts of Junior Assistant, Assistant, Superintendent and promote the petitioner in the existing vacancy to the post of Manager (Village Industries and Administration) in category - II of Tamilnadu Industrial Service.
