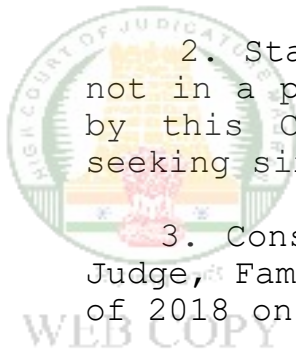

Earlier, this Court, while disposing of the appeals, by judgment dated 29.03.2021, directed the learned Judge, Family Court, Tiruchirappalli, to dispose of the H.M.O.P.No.44 of 2018, on or before 31<sup>st</sup> July 2021.



2. Stating that due to Covid - 19 Pandemic, the Family Court is not in a position to dispose the H.M.O.P.No.44 of 2018, as directed by this Court, the learned Judge, Family Court, Tiruchirapalli, seeking six months time to dispose of the H.M.O.P.No.44 of 2018.

3. Considering the said request, this Court directs the learned Judge, Family Court, Tiruchirapalli to dispose of the H.M.O.P.No.44 of 2018 on or before 21.12.2021.
