It is also seen that she married one Jegan and thereafter their whereabouts is not known. Phone numbers of the above said persons have not been received.

3.Considering the facts and circumstances of the case, let the investigation be completed by the second respondent within a period of six months from the date of receipt of a copy of this order by taking effective steps.



4.With the above directions, this criminal original petition is disposed of.
