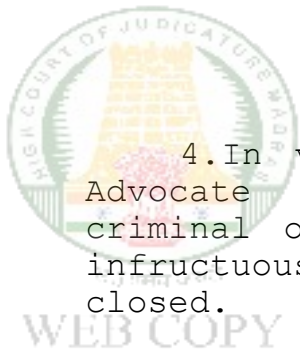

2.Heard Mr.B.Prahalad Ravi, learned counsel appearing for the petitioner, Mr.M.Muthumanikkam, learned Government Advocate (crl.side) appearing for the first respondent and Mr.I.Pinaygash, learned counsel appearing for the second respondent.

3.When the matter is taken up for hearig today, the learned Govt. Advocate (Crl.side) appearing for the State, on instructions, submitted that during the course of investigation, it was found that no documentary evidence was available with the second respondent with regard to the alleged transaction. Therefore, the respondent police closed the case as 'further action dropped' and RCS notice has also been served upon the second respondent.
