3.When the matter is taken up for hearing today, the learned Govt. Advocate (Crl.side) appearing for the State, on instructions, submitted that after completion of investigation, final report has



been filed before the learned Judicial Magistrate No.II, Madurai and the same was taken on file in C.C.No.309 of 2021 He further submitted that so far two witnesses have been examined before the trial Court.

4.In view of the submissions made by the learned Government Advocate (Crl.side), nothing survives for adjudication in this criminal original petition. If the petitioner is aggrieved by the contents of the final report, he shall work out his remedy through appropriate proceedings. Hence, this petition is dismissed as infructuous. Consequently, connected miscellaneous petition is closed.
