Prayer in WP(MD) . 2910/ 2017 :

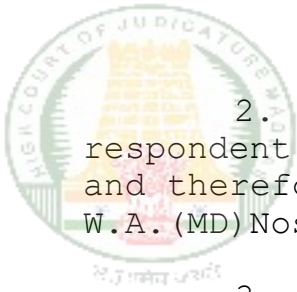

Higher Secondary School, Padanthalumoodu, Kanyakumari District with all attendant benefits, including arrears of salary and allowances and pass such further or other suitable order/ orders as this Hon'ble Court may deem fir and proper.

ORDER

The petitioner filed W.P.(MD)No.2910 of 2017 before this Court for non-approving his appointment as Record Clerk in the 5th respondent School with effect from 30.05.2005 to 06.02.2006. This Court, vide order 27.02.2017, allowed the writ petition and directed the 4th respondent to accord approval to the appointment of the petitioner as Record Clerk in the 5th respondent School with effect from 30.05.2005 to 06.02.2006 with all monetary and other service benefits.



2. The learned Special Government Pleader appearing for the respondent submitted that there was a ban from the year 2004 to 2006 and therefore, approval was not given. It is stated that appeals in W.A. (MD) Nos.328 and 329 of 2020 have been preferred.

3. In view of the above, the contempt petition is closed. Consequently, Sub A (MD) No.49 of 2018 is also closed.
