Prayer: Contempt Petition is filed under Section 11 of Contempt of Courts Act, to punish the respondents for committing contempt of Court by their wilful deliberate and disobedience of the order passed by this Court, dated 11.05.2017, made in W.P(MD).No.22920 of 2015.

Prayer in WP(MD). 22920/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus to call for the records in pursuant to the impugned order passed by the 3rd Respondent in Na.ka.No.92693/VI/E3/2008 dated 30.10.2013 and quash the same so far as the regularization of petitioner service from 14.02.2013 is concerned and consequently direct the Respondents to regularize the Petitioner services with effect from the date of initial appointment ie. from 03.06.2002 based on the recommendation made by the 4th Respondent in his proceedings Na.ka.No.8001/Aa1/2013 dt.03.05.2013 and to grant all monetary and service within a stipulated time may be fixed by the Court.
