Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the Respondents to regularise the petitioner's service in the post of Sweeper from the date of her appointment i.e. 21.09.1988 with all service and monetary benefits based on the petitioner's representation dated 26.08.2015 and 06.10.2017 within a stipulated period as fixed by this Honble Court.
