Prayer: Contempt Petition is filed under Section 11 of Contempt of Courts Act, to punish the contemnors/respondents for wilfully disobeying and not complying with the order of this Court dated 23.08.2016 in W.P(MD)No.14780 of 2016.

Prayer in WP(MD). 14780/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the 1st respondent to pay the petitioner Rs.6,29,413/- towards Gratuity, Rs.91,094/- towards leave salary and also arrears of wages for the period from 01.09.13 to 31.03.15 payable pursuant to new wage settlement dated 13.04.15 together with 18% interest per annum, along with interest amount towards the delayed payment of EPF Employees Contribution amount Rs,3,37,668/- for the period from 30.11.15 to 24.06.16 at the rate as per EPF Scheme and further directing the respondents to pay him Rs.2,60,070/- towards the Pension Commutation together with 18% interest per annum, within a time frame as may be fixed by this Honble Court
