Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the 1st respondent to pay the petitioner Rs.10,24,231/- towards Gratuity, Rs.6,05,581/- towards Leave Salary Rs.1,42,374/- towards encashment of leave on Personal Affairs Rs.50,000/- towards Social Security Scheme benefit and Rs.4,360/- towards refundable deposits together with 18% interest per annum along with interest amount towards the delay period from 31.05.2016 to 21.01.2017 in paying EPF Employee's Contribution amount Rs.4,44,222/- at the rate as per EPF Scheme and further directing the respondents to pay him Rs.4,00,301/- towards the pension commutation together with 18% interest per annum, within a time frame as may be fixed by this
