Prayer: Contempt Petition is filed under Section 11 of the Contempt of Courts Act, 1971, to punish the respondents/contemnors for their deliberate and wilful disobedience of the order of this Court in W.P.(MD).No.14369 of 2016, dated 24.08.2016.

Prayer in WP(MD). 14369/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the 1st respondent to pay the petitioner Rs.4,82,515/- towards Gratuity, Rs.3,11,166/- towards E.P.F. Employees Contributions, Rs.87,296/- towards Leave Salary and also arrears of wages for the period from 01.09.13 to 31.05.14 payable pursuant new wage settlement, together with 18% interest per annum further directing the respondents to pay him Rs.2,13,264/- towards the pension commutation amount and arrears of pension for the period from 01.06.14 by revising his pension, together with 18% interest per annum, after calculating all his terminal/pension benefits based on the monthly wages payable to him on the month of his retirement i.e., may 2014 by revising the same as per the settlement dated 13.04.2015, as ordered by the Hon'ble Division Bench of this Court its order dated 29.01.2016 made in W.A.(MD).No.1457 of 2015 and etc., batch.
