Prayer: Contempt Petition is filed under Section 11 of the Contempt of Courts Act, 1971, to punish the respondents/contemnors for their deliberate and wilful disobedience of the order of this Court in W.P.(MD).No.14626 of 2016, dated 23.08.2016.

Prayer in WP(MD). 14626 of 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the 1st respondent to pay the petitioner Rs. 8,46,512/- towards Gratuity, Rs. 8,53,950/- towards EPF Employees Contributions Rs. 5,51,373/- towards Leave Salary, Rs. 50,000/- towards Social Security Scheme benefit and also arrears of wages for the period from 01.09.13 to 31.03.15 payable pursuant to new wage settlement dated 13.04.15, together with 18% interest per annum and further directing the respondents to pay him Rs. 3,20,341/- towards the Pension , Commutation amount together with 18% interest per annum within a time frame as may be fixed by this Court.
