Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the 1st Respondent to pay the petitioner Rs.6,20,990/- towards Gratuity, Rs.2,06,000/- towards E.P.F. Employees Contributions, Rs.50,000/- towards Social Security Scheme benefit and also arrears of wages for the period from 01.09.13 to 31.03.15 payable pursuant to new wage settlement dated 13.04.2015, together with 18% interest per annum and further directing the respondents to pay him Rs.5,47,715/- towards the Pension Commutation, together with 18% per annum, within a time frame as may be fixed by this Hon'ble court.
