Writ Petition filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the 1st respondents to pay the petitioner Rs.4,94,880/- towards Gratuity, Rs.98,437/- towards Leave Salary and also arrears of wages for the period from 1.09.13 to 31.03.15 payable pursuant to new wage settlement dated 13.04.2015 together with 18% interest per annum, along with interest amount towards the delayed payment of EPF Employees Contribution amount Rs.2,03,697/- for the period from 31.07.15 to 28.05.16 at the rate as per EPF Scheme and further directing the respondents to pay him Rs.2,10,146/-towards the pension commutation together with 18% interest per annum.
