Prayer in WP(MD). 20652 of 2013 :

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records in connection with the impugned order of the respondent in proceedings Lr.No.D5/2513/97/Relief/G.O.115/2013 dated 05.07.2013 and quash the same as arbitrary and illegal and consequently direct the respondent to execute sale deed in respect of the house allotted to the petitioner bearing NO. MIG-B-23 without insisting /demanding any excess amount in the name of difference in Land Cost, interest and maintenance charges etc., and pass such further or other orders.

Prayer in WP(MD). 18033 of 2013 :

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus calling for the records in connection with the impugned order of the respondent in proceedings Lr.No.R5/2237/97/Relief G.O.115/2013 dated 5.7.2013 and in Lr.No.R5/2239/97/Relief G.O.115/2013 dated 5.7.2013 and quash the same as arbitrary and illegal and consequently direct the respondent to execute sale deed in respect of the house allotted to the petitioner bearing no.MIG-B-18 and MIG-B-25 without insisting/demanding any excess amount in the name of difference in land cost, interest and maintenance charges etc.
