ORDER:

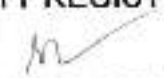
Heard learned counsel for petitioner and the learned Government Pleader for Revenue appearing for respondent.

As a sequel, miscellaneous petitions pending, if any, shall stand closed.

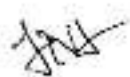
