In view of the reasons stated in the affidavit filed in support of the application, the condition imposed by this Court vide order dated 09.03.2021 in Crl.P.No.800 of 2021, directing the petitioner/unnamed accused to appear before the Station House Officer, Bowenpally Police Station on every Saturday between 10.00 AM and 2.00 PM., till filing of the charge sheet, is hereby modified directing the petitioner to appear before the said Station House Officer on 4th Saturday of every month instead of every Saturday. The other conditions shall remain unaltered.

Accordingly, I.A., is ordered.
