Tr.C.M.P. Nos. 27 and 59 of 2021

COMMON ORDER:

In Tr.C.M.P.No.27 of 2021, petitioner-wife seeks transfer of F.C.O.P.No.878 of 2020 from the Family Court, City Civil Courts, Hyderabad, to the Family Court, Malkajgiri.

In Tr.C.M.P.No.59 of 2021, petitioner-husband seeks transfer of F.C.O.P. No.32 of 2021 from III Additional Family Court-cum-XVI Additional District & Sessions Judge, Malkajgiri, Ranga Reddy District to the Family Court, City Civil Courts, Hyderabad.

Learned counsel for the parties submit that it would be inconvenient for both the parties to attend the respective Courts.

It may be noted that attending to the Courts is inevitable, more particularly, in the cases relating to matrimonial disputes, irrespective of inconvenience, if any to the parties. However, there has to be harmony between the parties and the best solution for both of them is to sit across and settle the dispute.

The statistics report discloses that as many as 1495 cases are pending before the Family Court, Malkajgiri and 1114 cases are pending in the Family Court, City Civil Courts, Hyderabad.

In those circumstances, F.C.O.P. No.32 of 2021 is withdrawn from III Additional Family Court-cum-XVI Additional District & Sessions Judge, Malkajgiri, Ranga Reddy District and transferred to the Family Court, City Civil Courts, Hyderabad to be

tried along with F.C.O.P.No.878 of 2020. Both the parties are at liberty to seek exemption of personal appearance by filing an application till the commencement of the trial after initial effort being made for reconciliation.

The Tr.C.M.Ps. are accordingly disposed of.

Miscellaneous applications, if any pending, shall stand closed.

There shall be no order as to costs.
