Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to quash the proceedings in FIR NO. 349 OF 2020 dt. 22/12/2020 on the file of SHO, PS, CCC Naspur, Mancherial District (erstwhile Adilabad District) which was registered as per the contents of the Petition filed by the Respondent No.2/Complainant under Section 190 R/w Section 200 Cr.P.C. against the Petitioner/Accused No.3 herein and 10 others alleging the offences under Sections 468, 471, 474, 420, 447, 427, 120(B), 143, 144, 506, 167, 192, 200, 418 IPC which was referred by the learned Principal Judicial First Class Magistrate, FAC I Additional Judicial Magistrate, Mancherial under Section 196(3) of Cr.P.C. to secure the ends of justice as the allegations made against the petitioner/accused are unsustainable in the eye of law and as such the continuation of proceedings is nothing but abuse of process of law and the court.
