the above Criminal Petition under the caption " For Being Mentioned" in order to seek
permission to modify the order dt:23/03/2021 to the extent of mentioning "Cash
Sureties" with "Cash Deposit" in order dt: 23/03/2021 in Crl.P.No.1967/2021.

This petition coming on for being mentioned for hearing upon perusing the
Petition and affidavit filed in support thereof and upon hearing the arguments of
Ms.Divya Adepu, Advocate for the petitioner and of the Public Prosecutor for the
Respondent.

The Court made the following: ORDER

Heard.

This application is filed by the petitioner to correct the order dated 23.03.2021
passed by this Court in Crl.P.No.1967 of 2021 by incorporating the cash deposit for
Rs.10,000/- each in stead of cash sureties.

It is contended by the learned counsel for the petitioner that the petitioner is a
Foreigner, native of China and he is not in a position to furnish cash sureties. He would
further submit that instead of furnishing cash sureties, the petitioner is in a position to
deposit cash, therefore, he sought to modify the order dated 23.03.2021 to that effect.

Perused the order dated 23.03.2021. It is no doubt that the petitioner is a
Foreigner, native of China. In the said circumstances, the petition is ordered modifying
the order dated 23.03.2021 to the following effect.

"The petitioner/A-1 is permitted to deposit Rs.20,000/- cash" instead of
"furnishing two cash sureties of Rs.10,000/- each".

Accordingly, this application is ordered.
