Ram Mohan, learned AGP for Home, on instructions, would submit that on the complaint lodged by Ms.Mounika, D/o.M.sudhakar Rao - petitioner in W.P.No.8477 of 2021, the Police have already registered a case in Crime No.336 of 2021, for the offences under Sections 376-D, 323, 384 and 341 of IPC. Since the allegations in the complaint of the petitioner herein, who is sister of petitioner in W.P.No.8477 of 2021, are similar and Police have registered the above said crime, there is no need of registration of one more crime with regard to very same allegations.
