Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more in the nature of Writ of Mandamus, declaring that the action of the 3rd respondent, in issuing the Office Order No. 1084/A3/ESTT/TSIRD/2016, dated 30.03.2021, holding that the petitioner-firm was in block list for a period of 5 years, without giving any notice or an opportunity to the petitioner to represent his case, by duly cancelling the agreement dated 15.02.2017 which was extended from time to time till the impugned order was issued by the 3rd respondent, dated 30.3.2021, as illegal, arbitrary, contrary to the guidelines issued of the Agreement executed by the 4th respondent with the petitioner, violative of principles of natural justice, violative of Article 14 and 21 of the Constitution of India and set aside the same, by holding that the petitioner is eligible and entitled to get extension of the Agreement for the purpose of Sai Krupa Catering and Maintenance Service on such terms and conditions of the Agreement dated 15.2.2017, which was extended from time to time.
