ORDER:

This Criminal Petition, under Section 482 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A7 seeking to quash the proceedings in Crime No.237 of 2013 on the file of Golconda Police Station, Hyderabad.

2. Heard. Perused the record.
3. On written instructions, dated 17.02.2021, learned Additional Public Prosecutor would submit that in the subject crime, investigation is completed and charge sheet is filed before the XVII Additional Chief Metropolitan Magistrate, Hyderabad.
4. In that view of the matter, the cause in this Criminal Petition does not survive for adjudication.
5. Accordingly, the Criminal Petition is dismissed as infructuous. However, the petitioner/A7 is at liberty to avail the remedies available under law.
